Section 3 -- HAZARDS IDENTIFICATION

ROUTES OF EXPOSURE: Exposure may be by INHALATION and/or SKIN or EYE contact, depending on conditions of use. To minimize exposure, follow recommendations for proper use, ventilation, and personal protective equipment.

EFFECTS OF OVEREXPOSURE: Irritation of eyes, skin and upper respiratory system. May cause nervous system depression. Extreme overexposure may result in unconsciousness and possibly death.

SIGNS AND SYMPTOMS OF OVEREXPOSURE: Headache, dizziness, nausea, and loss of coordination are indications of excessive exposure to vapors or spray mists. Redness and itching or burning sensation may indicate eye or excessive skin exposure.

MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE: None generally recognized.

Section 4 -- FIRST AID MEASURES

IF INHALED: If affected, remove from exposure. Restore breathing. Keep warm and quiet.

IF ON SKIN: Wash affected area thoroughly with soap and water. Remove contaminated clothing and launder before re-use.

IF IN EYES: Flush eyes with large amounts of water for 15 minutes. Get medical attention.

IF SWALLOWED: Do not induce vomiting. Get medical attention immediately.

UNUSUAL FIRE AND EXPLOSION HAZARDS: Closed containers may explode (due to the build-up of pressure) when exposed to extreme heat. Application to hot surfaces requires special precautions. PRECAUTIONS TO BE TAKEN IN HANDLING AND STORAGE: Keep away from heat, sparks, and open flame. Vapors will accumulate readily and may ignite explosively. During use and until all vapors are gone: Keep area ventilated - Do not smoke - Extinguish all flames, pilot lights, and heaters - Turn off stoves, electric tools and appliances, and any other sources of ignition. Consult NFPA Code. Use approved Bonding and Grounding procedures. Contents under pressure. Do not puncture, incinerate, or expose to temperature above 120°F. Heat from sunlight, radiators, stoves, hot water, and other heat sources could cause container to burst. Do not take internally. Keep out of the reach of children.

Section 8 -- EXPOSURE CONTROLS/PERSONAL PROTECTION

PRECAUTIONS TO BE TAKEN IN USE: Use only with adequate ventilation. Avoid contact with skin and eyes. Avoid breathing vapor and spray mist. Wash hands after using.
